About the event

Managing New Realities was established in 2003 to bring together the worlds of health, social care and housing to discuss the commissioning and provision of integrated and personalised services for adults. The event has quickly developed to become the primary opportunity for the sectors to meet and work together to forge a common, innovative and challenging agenda for service development.

Personalisation and choice continue to be the government's twin mantras. We see this reflected in individual budget pilots in social care, the Expert Patients programme in health and some of the more creative Supporting People schemes in housing. And whatever the political future holds, it is certain there will be a growing plurality of organisations delivering services. Charities, social enterprises and for-profit companies will all have expanding roles to play.

Managing New Realities 2007 will examine what each of these sectors can bring to the table. Most users of services and carers want services that are safe and seamless, responsive and tailored to their needs, irrespective of who delivers them. But what is distinctive about statutory, voluntary and for-profit providers? What else do they contribute to the mix?

Why is the conference different?

Over two days of reflection and debate, we shall have presentations of best practice. We'll hear throughout from users and carers and, in the now well-established Managing New Realities format, use lively round-table discussion groups to pose probing questions. We'll have a special focus on the hot topic of social enterprise, facilitated by the King's Fund, and we'll of course have keynote presentations from senior ministers.

As in 2006, there will be a published post-conference report. Our aim, as ever, will be that participants go back to their own teams fizzing with fresh enthusiasm and new ideas that can have an immediate practical impact.
