Making sure your relative is safe

We are looking for case studies – can you help?

# Family carers have a vital role to play in all aspects of safeguarding; from helping their relatives stay safe to responding when they have been harmed.

Because of the urgent need for clear information to support family carers in their safeguarding roles, the National Family Carer Network (NFCN) is working with partners to develop THREE free *Making Sure Your Relative is Safe* resources for relatives and friends of people with learning disabilities.

Two of these will be available from the NFCN in June:

- 1) *Top Tips* about the part family carers can play to make sure that adult safeguarding works for a relative.
- 2) A Family carers' Essential Guide to safeguarding adults with learning disabilities.

A third will be published by Hft's Family Carer Support Service this autumn:

3) A *Resource Pack*, including a dvd, providing detailed advice and information about safeguarding in specific circumstances.

### We are looking for case studies that will illustrate the following scenarios:

 Experiences of using person-centred planning and circles of support to keep a relative safe and well

- Examples of using practical resources (such as Keep Safe training) to help keep a relative safe and well
- Experiences of dealing with bullying, 'mate crime', harassment etc
- The safety aspects of employing care staff (e.g. carrying out checks)
- Consideration of safety and well-being when a relative moves away from home (positive and negative experiences)
- Safety and well-being when a relative requires medical treatment (using acute services, long-term medical conditions, using mainstream health services etc)
- Raising concerns about physical or emotional harm to a relative or neglect of a relative
- Raising concerns about financial abuse of a relative
- Examples of resolving issues with a service provider
- Experiences of a relative being involved in a safeguarding process
- Experiences of a relative being involved in a criminal investigation
- Dealing with an allegation of harm made against a family carer

#### We are looking for contributions from a number of perspectives - though the focus will remain on the role that family carers have played, and can play. These might include:

- Family carers with direct experience of the above
- Adults with learning disabilities
- Family friends and members of circles of support
- Family carers as lay inspectors, quality checkers and otherwise involved in regulation of services
- Family carer representatives on Safeguarding Adults Boards
- Safeguarding Adults Board members
- Safeguarding adults professionals
- Service provider personnel with responsibility for safeguarding
- Healthcare and social care professionals
- 'Frontline' paid care staff
- Advocates and advisors, lawyers & academics

Find out more about Devon Grapevine – a networking and information site for people from different cultures living in Devon. Get tips on useful on-line translation tools. Learn about the Afiya Trust's 'Living in the Margins' social media based campaign and their interim report on the impact of public sector cuts on BME families and voluntary and community groups.

See the Personalisation Section to learn how organisations such as Grapevine in Coventry are supporting young people from different ethnic backgrounds to use their personal budgets. Find out how BME Carers are being supported and get new information on projects happening in Barnet, Croydon, Telford and Wrekin. Read about specific communities for example what the Chinese Centre in London can offer. If you are not sure how to engage with the Gypsy Roma Traveller Community read Leeds' Gypsy and Traveller Exchange's toolkit 'How to engage with Gypsies and Travellers as part of your work.'

#### 3. CQC Learning Disability review final 10 reports

On 9<sup>th</sup> May the Care Quality Commission (CQC) published a further 10 reports from a targeted programme of 150 unannounced inspections of hospitals and care homes that care for people with learning disabilities.

## 4. Leeds Animation Workshop's DVDs for people with a learning disability

Two new DVD resources on health, designed especially for people with learning disabilities.

Also suitable for awareness-raising and training NHS staff.

Produced by Leeds Animation Workshop with funding from the Department of Health.

Each DVD pack consists of a short animated film and booklet. One is about primary care and one about hospital care. All the voices on the soundtrack are those of actors with learning disabilities.

GETTING BETTER contains 6 stories, each about 2 minutes long, and an easy-read illustrated booklet.

Each story shows a character going to the doctor's, or the clinic, or having an eye test, or visiting the dentist.

It shows people asking questions, and speaking up for themselves.

SAPHIA goes to see the doctor about her cough. She finds out about making appointments, and asks for information to be given in a clear way.

GARY can't walk or talk. He goes to the GP with a carer. The GP asks the carer for input, addresses Gary directly, and demonstrates procedures for him.

DIANA goes for a smear test with her mum. The nurse uses pictures and explains the procedure beforehand.

GEORGE goes to the clinic for his annual health check. The nurse takes his blood pressure. The doctor and George make a health action plan together. JONATHAN goes to the dentist with his dad. He finds it difficult when he is kept waiting and is referred to the special dentistry service.

PAULETTE has never had an eye test, because she can't read. She goes to the optician with a care worker.

GETTING BETTER IN HOSPITAL is a sequel. This too is a DVD with 6 stories, about the same characters, with an easy-read illustrated booklet. Watch a clip here:
