Children and young people with learning disabilities and autism often have associated expressive, receptive or social communication difficulties. Emotional and behavioural problems can at times be an outward expression of difficulties communicating with others. Equally communication difficulties can make it harder for young people with learning disabilities and/or autism to express themselves and communicate their emotional distress.

Conference Aims: This conference aims to provide practitioners working with children and young people with learning disabilities and autism with an understanding of these communication difficulties and ways of working when words are not enough to enable meaningful interaction, communication and emotional expression.
