Anne McGuire MP Minister for Disabled People



Anne McGuire, MP for Stirling, was elected to the House of Commons in May 1997. She was the Parliamentary Private Secretary to the Secretary of State for Scotland from November 1997 to July 1998. In July 1998, she became an Assistant Government Whip and was appointed a Lord Commissioner to the Treasury in June 2001. In June 2002 she became Parliamentary Under Secretary at The Scotland Office before becoming Minister for Disabled People in 2005.

She was Deputy Director, Scottish Council of Voluntary Organisations. She has also been a member of the Children's Panel and a Safeguarder for Children. She is also a Vice President of the Commonwealth Youth Exchange Council. She has been a senior member of the Labour Party's Scottish Executive and was chair of the party in 1992/93.

Jeremy Hunt MP Shadow Minister for Disabled People



Jeremy was elected Conservative Member of Parliament for South West Surrey in May 2005. In December 2005 Jeremy was appointed Shadow Minister for Disabled People. Jeremy has long had an interest in social issues, and is using his Shadow Ministerial position to campaign for a better deal for parents of severely disabled children and for carers. He is also pressing for simplification of the highly complex benefit system as it affects disabled people and for the removal of all disincentives in the system that prevent or discourage disabled people from working.

He has a particular interest in international development, and is a member of the International Development Select Committee. Together with a business partner he set up Hotcourses Ltd, the UK's largest publisher of guides and websites to help people choose the right school, college, university or course.

Sara Harrison Diversity and Development Project Manager, ITV



Sara Harrison started with ITV over six years ago as the Training Manager for ITV Yorkshire. As well as responsibility for staff training & development, her role involved building partnerships between educational institutes and community organisations.

Following the success of various diversity initiatives her role changed in February 2004 to ITV Diversity and Development Project Manager; with the remit of rolling out best practice for diversity, development and educational initiatives across the ITV group.
