In 2007, a joint working group of the Royal College of Psychiatrists and the British Psychological Society, in consultation with the Royal College of Speech and Language Therapists produced a new Council Report, 'Challenging behaviour: a unified approach'. The report provides clinical and service guidelines for supporting people with learning disabilities who present behavioural challenges and are at risk of receiving abusive or restrictive practices. The working group was greatly assisted by Professor Jim Mansell who at the same time has been revising his original report of 1993 on services for people with learning disabilities and challenging behaviour and with mental health needs.

Together, these reports aim to give fresh impetus to service development and delivery and to reassess and redefine key concepts and approaches in this area. They are groundbreaking in their uniting of professional approaches and guidance, and in a redefining of challenging behaviour and the capacities that need to be developed throughout services from the statutory and independent sectors. A commitment to the recommendations and guidance in these reports, at all levels, could herald an exciting new era in the support of people whose behaviour presents a challenge.
