The law and processes relating to children's social care are complex and frequently changing. This interactive course will clarify the duties local authorities have to support children and families, and will set out the proper procedures that should be followed when there is a genuine concern for a child's welfare and/or safety.

By the end of the course we hope that you will be better able to support parents whose children are involved with children's social care services, and will be more equipped to help parents access the support they need.

By the end of the day participants will:

- Have gained an understanding of law and processes in relation to family support, or when families may need help with their parenting or other assistance from the local authority.
- Have a basic understanding of law and processes relating to child protection.
- Understand the duties of local authorities to involve families in planning for their children.
- Have shared ideas, experience and best practice of providing advocacy for parents who are negotiating with the local authority about service provision.

Who should attend:

People supporting parents who have involvement with children's social care services. e.g. MIND, FWA, MENCAP, voluntary sector drug and alcohol workers, as well as CAB advisers and others working in community settings.
