## **About the workshop**

The Mental Capacity Act (2005) came into force in 2007 and has wide ranging implications for all health and social care professionals who provide services to people with learning disabilities. The Act requires that staff and carers are clear about what capacity is and how to determine whether or not a person with learning disabilities has capacity in relation to a specific decision. It also requires that if the person does not have capacity that specific steps are taken to ensure that decisions are made in the person's best interest. These workshops will explore the practical implications of implementing the Mental Capacity Act in relation to people with learning disabilities.
