# **NEW** Criminal Offence and IMCA service from 1 April 2007

## **NEW** Criminal Offence and IMCA service from 1 April 2007

On 1 April 2007 the new **criminal offence** of ill treatment or wilful neglect will come into force in England and Wales and the new

## Independent Mental Capacity Advocate (IMCA) service will become operational in England.

The new criminal offence will apply to anyone caring for a person (of any age) who lacks capacity to make decisions for themselves. This includes family carers, healthcare and social care staff in hospitals and care homes and those providing care in a person's home. The new offence carries a range of penalties from a fine to a prison sentence of up to five years.

Sections 1- 4 of the Act (*the principles, assessing capacity and determining best interests*) which are essential to how IMCAs will operate also comes into force **but** only in situations where an IMCA could be involved, and for the purpose of the criminal offence. Sections 1–4 of the Act will **not** apply in any other situations until October 2007.

The Code of Practice for the Act is due to be formally issued in late April, once it has completed the necessary Parliamentary processes. From this point it should be followed by those who must have regard to it in situations where an IMCA could be involved, or in relation to the criminal offence. It will also be available as a good practice guide for all those working with people who may lack capacity. Once the rest of the Act's provisions come into force in October 2007, the Code will become statutory guidance for all of the Act.

## **IMCA** service update

The IMCA service will become operational on 1 April 2007 in England and on 1 October in Wales.

# **IMCA** service in England

All local authorities (LAs) in England have finished commissioning the new IMCA service, which will be ready to start on 1 April 2007. NHS staff and LA staff will need to know when they have a duty to refer people to the new IMCA service. IMCAs will be ready to take referrals and work with people who qualify for the service from 1 April. The Department of Health (DH) is developing a database, which will monitor numbers and types of referrals to the IMCA service. A database of IMCA providers will be available on the DH website shortly.

#### **IMCA** service in Wales

The The IMCA Regulations for Wales were approved by the National Assembly for Wales on 13 March and will come into force on 1 October 2007. These include Regulations giving local authorities and local health boards the discretion to extend the IMCA service to care reviews and adult protection cases.
