## Why attend this conference?

The conference will look at the interface issues between the Mental Capacity Act (2005) and other legislation.

Significant interface issues exist with the Human Rights Act (1998); National Assistance Act (1948); Children Act (1989); Mental Health Act (1983) (2007); Sexual Offences Act (2003) & Criminal Procedure Act (1991).

- The Mental Capacity Act 2005 ultimately affects decisions that relate to property, financial affairs, health, and personal welfare.
- Although civil legislation the MCA 2005 created a criminal offence for the neglect of a person without capacity.
- Increasingly the thinking enshrined in the MCA 2005 is extending within criminal law
- As awareness of the increasing scope of the Act is recognised it is important to keep appraised of the latest developments in thinking and practice. The conference gives a clear snapshot of the current state of play and potential developments.
- Specifically the conference will provide opportunities to discuss implications of the Act not only within a legal context but also within medical and care settings.
- Attendance at the conference will inform your decision making and provide access to continuing sources of information and support
