## ABOUT THE CONFERENCE

This conference is aimed at all clinicians and commissioners who work in secure mental health settings with a clear emphasis on the nursing profession. The speakers and workshops will engage, inform and inspire staff at all levels with up-to-date guidance and knowledge to take back to the workplace.

Key speeches from Dame Christine Beasley and our conference Chair, Dr Ben Thomas, will set the scene for the event, followed by expert presentations on relational security, management of violence, inpatient suicide and an expert service user who will contribute with his experience to date.

The afternoon session offers delegates the opportunity to attend 2 workshops. Each workshop shall be repeated twice giving delegates a greater choice from the wide variety of topics, ranging from discussions on mental health provision in prisons, managing of difficult behaviours and relationships, and the creation of a healing environment.

Refreshment breaks will allow time for delegates to experience an art exhibition provided by the Koestler Trust, the UK's best-known prison arts charity who have been awarding and exhibiting artworks by offenders, detainees and secure patients for 47 years.

## AIMS OF THE CONFERENCE

The conference aims to improve each delegate's knowledge and enhance their practical workplace skills.

The event will provide a forum for the delegates to engage in open debate about the controversies regarding the role of nursing in secure mental health services through panel discussions. It is hoped that delegates will have a chance to challenge their own beliefs and hear a variety of views from the conference speakers and other delegates.

- The latest relational security guidelines
- The management of violence and suicide within secure settings through hearing of others experiences and successes
- The key issues facing all involved in secure mental health nursing
