Attitude Awards 2010

On Wednesday 1 December, the Attitude Awards were held at Eden Park. These awards, in their third year, showcase the fantastic achievements of New Zealanders living with disabilities.

The Ministry of Health was delighted to sponsor the Artistic Achievement Award. Director of the National Health Board, Chai Chuah, presented the winner Celeste Strewe with the award. Celeste is a young woman who has severe hearing loss and dyslexia. She uses hearing aids and lip reads, making communicating a challenge. Working 14 hour days as a make-up artist, Celeste has a number of film credits under her belt. Celeste also won the Best Emerging Artist Award at the Body Art Awards in October this year. Celeste's father is an artist, her mother a jewellery maker and her brother a sculptor, so

creativity runs in the family. Her hearing loss and teasing at school left her feeling isolated and art was a way for her to express herself. Her success has made her start believing in herself. Her dream is to be the head make-up designer on a big scale film production.

Attendees from the Ministry of Health described the event as inspirational and humbling. New model for supporting disabled people - update

Demonstration project

As updated in the last newsletter, the first demonstration project of the model will be in Western Bay of Plenty/Tauranga.

Inclusion Aotearoa has been selected as the implementation support organisation to help with the design, implementation, testing and refinement of the demonstration project.

The Directors of Inclusion Aotearoa are Ruth Gerzon and Lawrence Chok. Ruth has many years' experience supporting the inclusion of disabled people through training and community development roles (including helping to set up People First's National Office). Lawrence has, in recent years, helped establish family governed services, circles of support and micro businesses, and has a background in business and health management in several countries.

They are currently preparing a profile of the Western Bay of Plenty/Tauranga region, arranging introductions for the Ministry to the community, and working toward establishing a local working group and national reference group for the demonstration project. DSS's Jenny Moor and members of the project team have been discussing the new model with disabled people and others in both Bay of Plenty and nationally. They have also attended the recent provider forums, and will be introducing themselves along with Inclusion Aotearoa at a stakeholder meeting in Tauranga before Christmas.

We will continue to provide updates via our newsletters and website as we develop the model and people will be able to contribute via disability consumer and provider representatives on the local working group, national reference group and DSS Consumer Consortium.

Environmental Support Services (ESS)

A number of projects are continuing which will support ongoing improvements to the provision of equipment and modifications, and also help manage the increased demand for these services. These include:

- 1. Assessor Accreditation
- NASC and EMS Guideline for High Cost and/or Complex Applications

Child and Youth

- The guideline on 'Roles and Responsibilities for Supporting Disabled Children and Young People under the Children, Young Persons and Their Families Act 1989' is available on the Ministry of Health website.
- Disability Support Services have initiated the development of a broad disability services focused Action Plan for Children and Youth, incorporating strategic priorities and government directions
- Child Development Service Specification Population Health's Child and Youth Team
 are updating all of the Child Health service
 specifications. Disability Support Services has
 reviewed the DSS Child Development Service
 Specification (DSS1012) to update in line with
 their changes.

Review of the Equipment & Therapy protocols

- The revised Therapy and Assistive Technology/ Equipment Operational Protocols between the Ministry of Education and Ministry of Health are complete. The protocols can be viewed at http://www.moh.govt.nz/moh.nsf/pagesmh/10063/\$File/therapy-assistive-technology-operationalprotocols.doc.
- Speech-Language Therapy The Ministry of Health has scoped the work required to align practice, and more clearly define roles and responsibilities that will allow the inclusion of Speech Language Therapy in the revised Ministry of Health and Ministry of Education Operational Protocols.

Autism Spectrum Disorder (ASD)

- Implementation of the NZ Autism Spectrum Disorder Guideline continues based on the agreed priorities.
- The implementation of a Developmental Coordinator function within DHBs is a new initiative. This function will focus on the referral and assessment processes and post diagnosis coordination for children and young people with developmental concerns.
- The proposals for the ASD-specific Behavioural Support did not meet all of the criteria required. The decision was made to discontinue the process and link this initiative into the sector wide review of Behaviour Support.
- The Ministries of Health and Education are jointly completing the evaluation of the NAS Earlybird, and ASD Plus: Education for Change.

Workforce

Training Grants - A one-off training grant 'open round' was made available for workers.

Leadership Development Grants and Consumer Leadership Development Grants - These grants was open from 1 September to 31 October 2010. A stream of applications have been received for courses to be undertaken in the 2011 academic year.

Graduate Diploma in Education - Disability
Support specialisation - An evaluation
component is currently being developed by
the Ministry of Health in consultation with the
University of Auckland to look at the effect of
the course on service delivery. The University
of Auckland continues to deliver the graduate
diploma to a total of 21 enrolled trainees for the
2010 course intake and 13 year two students from
the 2009 intake.

National Certificate in Disability Support
Assessment, Planning and Coordination Options for funding additional supports for the
23 current course trainees are being explored.
These supports include funding roving assessors
and an online support forum to assist students to
complete this qualification.

Disability Workforce Information Project-

DHBNZ continue to work on engaging and collecting information from providers for the final report.

Carers' Strategy - A request for proposal process commenced in November which aims to identify a contractor/agency to work on two key actions of the Carers' Strategy which relate to disability workforce development.

Individualised Funding (IF)

As of 13 October there are 504 IF clients. Extension of IF hosts is continuing with the Ministry now contracting with an additional 12 home and community support service (HCSS) regional and national providers who will become contracted IF Host Providers.

Residential services for people with a physical disability

An Implementation Options Plan has been presented to the Project Steering Group. This

plan provides a program of work for the next three years to implement the recommendations.

Review of Residential Services

We have had a series of discussions with external groups about the design of the Review of Residential Services. So far we have met with the National Assembly of People with Disabilities, the Consumer Consortium, the Consumer Coalition and a number of providers. A consumer reference group will be established along with a provider reference group, to guide the Review.

Supported Living Project

Service Specification - The Supported Living Service Specification review is complete other than the reporting requirements.

Operational Framework - Over the last 6 months the focus of development work has been on preparing an Operational Framework. Development of the document has included input from the sector, other government agencies and a small group of self-advocates representing users of Supported Living. During discussions about the Service Specification it was agreed that reporting on Supported Living should be changed to reflect a focus on outcomes.

Templates - Templates to support consistency across the country have been drafted. These will be reviewed once agreement has been reached about the content of the Operational Framework and the reporting requirements..

Consumer Consortium

A successful three-day consortium was held in early October. The focus for the three days was on new projects and innovation in Disability Support Services (DSS). The Hon Minister Tariana Turia spoke to the group and commended them for their advice and input into the work.

Spectrum Care wins silver in Business Excellence awards

Spectrum Care is an independent charitable trust that provides services for children, young people and adults with disabilities and their families.

The New Zealand Business Excellence Foundation presented a prestigious silver award to disability support provider Spectrum Care at their annual awards ceremony, held on Friday 26 November 2010.

In receiving this internationally recognised accolade, Spectrum Care has become the only health and disability sector organisation in New Zealand and one of only 14 organisations nationally to receive a silver or gold award since the Business Excellence awards commenced in 1997.

"We continue to aim high and improve ever further in our capacity to achieve our Vision of 'People with disabilities living great lives'," noted Chief Executive Chris Harris. "In fact, our next milestone will be to achieve a gold award, the world's highest-possible quality award for business excellence.

"In working towards this award, we've made enormous progress in terms of Outcomes, Active Support, training, family engagement and our collaborative approach to sector partnerships. It's also become clear that the lives of the people we serve have changed for the better as we work towards greater community inclusion and genuine person-centredness.

"This award is a truly significant result for the people we support, their families, our funders and the disability sector as a whole."







World Health Organization

On International Day of Persons with Disabilities, 3 December, preparations began for the launch of the World Report on Disability on 9 June 2011 in Geneva. This major report, published jointly with the World Bank, provides evidence on the current situation of people with disabilities, and identifies ways of removing barriers to the participation of people with disabilities in their communities.

WHO want to hear from people with disabilities about what can be done to overcome barriers. To start the debate, they asked Faustina Urassa, a woman with disabilities from Tanzania, "What's disability to you?" In the run up to the launch, they welcome your photographs, stories and short films on the theme "This is disability to me".
