The law and processes relating to child protection are complex. Supporting parents faced with this system can be daunting for many reasons.

This **intermediate** level course will use case studies to look at when and how a local authority can be involved in the lives of families. It will consider the duties and responsibilities of children's social care agencies. The course will also consider best practice in providing parental advocacy. This course will help those providing parental advocacy to improve existing practice, and help those who have not yet provided advocacy to prepare for this role.

By the end of the course we hope that you will be more able to support parents whose children are involved with children's social care. And will be better equipped to build effective partnerships with the local authority.

By the end of the day particpants will:

- Understand at what point a Local Authority has to get involved in a child's life, what the local authority should do, and what can happen to the child.
- Have a clear understanding of what significant harm is defined as.
- Be clear about the responsibility of the local authority to work in partnership with parents
- Understand the duty of the Local Authority to consider other family members for placement of the child if he
 or she can't go home
- Have considered the framework for professional parental advocacy, including confidentiality policy, independence, specialist knowledge and non-confrontational style.

Who should attend:

Anyone advocating for parents who have involvement with children's social care services, and will therefore be attending child protection conferences.

e.g. MIND, MENCAP, FWA, voluntary sector drug and alcohol workers, as well as CAB advisers and others working in community settings.
