

Pathological Demand Avoidance

Pathological Demand Avoidance Syndrome (PDA) is increasingly recognised as part of the autism spectrum. It is a lifelong disability that affects boys and girls equally. People with PDA need different amounts of support depending on how their condition affects them. The main difficulty for people with PDA is their avoidance of the everyday demands made by other people, due to their high anxiety levels when they feel that they are not in control. However, because they tend to have much better social communication and interaction skills than other people on the spectrum, they can use those skills to disguise their resistance through common avoidance behaviour.

As a result, people with PDA usually experience increased difficulty throughout their lives. They often imitate inappropriate behaviour or come across as overbearing, and may exhibit an obsessive desire to dominate socially. This behaviour can be extremely disruptive within classroom settings and may make for a chaotic and distressing home life.

This conference will give you a greater understanding of PDA and an opportunity to discuss strategies and techniques that will help you support people with the disorder, both at school and at home. You'll be able to hear the latest research on changing diagnostic understandings, as well as an in-depth discussion of educational strategies for teachers. There will also be presentations on approaches to managing behaviour and issues with communication.

Terms & conditions

Conference fees

Payment

Payment must be received before the conference date. If payment is not received by this time, delegates will be required to guarantee payment by credit card on the day of the conference. Cheques should be in pounds sterling and should be made payable to 'The National Autistic Society'.

Cancellations and refunds

Delegates who wish to cancel their places must do so in writing. If notice of cancellation is received at least 21 days prior to the event, the NAS will refund the full registration fee less £50 administration charge. If notice of cancellation is not received within 21 days prior to the conference, then we regret that no refund can be made.

Substitutions can be made without charge up to three days prior to the event. In the event that the NAS has to cancel the event, delegates will be given as much notice as possible and given a full refund (if paid in full) or a credit note (where payment is not yet made). We regret that we will be unable to compensate delegates for any travel or accommodation costs incurred.

Overseas delegates

EU countries: Delegates attending from EU countries are exempt from paying VAT only when their organisation is VAT registered within their own country.
