
# Ensuring that the Mental Capacity Act (MCA) is implemented in a way that maintains the rights of people with learning difficulties

If people are not aware of their rights within this Act, how will they know that their rights are being denied? So we are asking the Department of Health to provide more funding for raising people's awareness of the Act.



#### To ensure that people with learning difficulties are really included in their local communities.

We want to ensure that people have person-centred plans that identify the support they need to be part of their local communities. We want to lobby Partnership Boards with your support. This is to make sure that they work together to make community inclusion a reality.

# Closure of homes managed by the health services (NHS and private hospitals). They are called "campuses".

We are clearer about the numbers of people living in NHS campuses now. The Government has set aside money for new homes for these people. We want to make sure that you go away from the conference with some ideas about what you can do to make sure that people move to new homes which are suitable for them. People should be able to choose who they live with and select the staff who will support them.
