## National

### 1. CSA response to the draft Care and Support bill pre-parliamentary scrutiny consultation

The [Care and Support Alliance](#) (CSA) was set up in July 2009 and is a consortium of over 60 organisations that represent and support older and disabled people, including disabled children, those with long-term conditions and their families, and campaigns to keep adult care funding and reform on the political agenda.

NFCN are members of the Care and Support Alliance and therefore our views have been represented in this submission, which is available to read on our website [here](#).

### 2. Another council loses High Court battle over fees for care home providers

Redcar and Cleveland Borough Council has become the latest local authority to be successfully challenged in the courts by care home providers over its proposed level of fees.

The claimants in [Redcar and Cleveland Independent Providers Association & Ors, R \(on the application of\) v Redcar and Cleveland Borough Council](#) [2013] EWHC 4 represented more than 80% of homes for the elderly in the area.

### 3. Centre for Welfare Reform report

[The Centre for Welfare Reform](#), on behalf of the [Campaign for a Fair Society](#), has researched and published a detailed analysis of how the cuts target disabled people and people in poverty. The report goes on to explore the political factors that have led to such a significant attack on the rights of disabled people.

#### 4. **WELD Blog: Speech and language therapy screening tool in forensic service shows link between communication difficulties and offending behaviour**

One outcome measure of forensic services is the rate of re-offending. The author of this review was interested in this outcome, but in particular the contribution to this of speech and language therapy services.

The [Royal College of Speech and Language Therapists](#) recommend the involvement of speech and language therapy intervention in support to people to reduce re-offending, and the author set out to analyse referrals to the speech and language therapy department within a forensic support service for adults with learning disabilities.

Reports of disability hate crime have trebled in one area of the country after the Government worked with a local charity to encourage disabled people to come forward.

The use of 'third party reporting centres' has seen the number of incidents reported in Blackpool treble to 36 since the project began.

[Disability First](#) launched the service after feedback showed disabled people often feel more comfortable reporting hate crime incidents to people they know.
